# Rules of the Brotherhood of the 'Toqués du Col de Portes'



Challenge yourself, on the date that suits you, to cross the threshold of the col de Portes (Ain) in the same day as many times.

#### Article 1: Objective of the test

The objective for challengers is to make at least two ascents of the Col de Portes (one on each slope: Rhône and Albarine/Furans).

The cyclist will try to cross the Portes pass two to five times. He will have the choice between 8 towns or villages starting.

On the Rhône slope: Lagnieu, Sault-Brénaz, Serrières-de-Briord and Montagnieu (Les Granges). On the Albarine/Furans slope: Torcieu (Montferrand), St Rambert-en-Bugey (Serrières), Argis and Contrevoz.

Participation with an electric bike is accepted and will be the subject of a special ranking in the list.

#### **Article 2: The ranks**

Access to the brotherhood of the chaps of the Col de Portes is through 4 grades depending on the number of ascents made.

Key door (Porte-Clés) : 2 ascents made.

Locksmith (Serrurier): 3 ascents made.

Great Locksmith (Grand-Serrurier): 4 ascents.

Passe-Partout: 5 ascents including one from Torcieu passing through the Col de Fay.

Grand Passe Partout : 6 ascents including one from Torcieu

passing through the Col de Fay.

# **Article 3: Registration and Registration**

To participate, cyclists will first have to register (either by sending the registration form by post or by digital site Helloasso). No validation will be accepted without prior registration. Schedule this registration fifteen days before the expected date of its attempt. Registration is valid for the slippery year.

To approve the challenge, cyclists must either use the scoreboard (see practical tips on the site dedicated to its use) or send the organizer the GPS traces or Relive of their performance.

After returning these items, the new member will receive email his numbered diploma indicating his rank and rank in the brotherhood.

#### **Article 4: Registration fees**

The registration fee is 6 euros. Payment by cheque payable to the 'Roue Sportive de Meximieux' to be returned with the registration form to the manager or by CB via the HelloAsso website.

## Article 5: Security and ecocitizenship

The Brotherhood of 'les Toqués du Col de Portes' is not a competition.

The participants are considered to be on a personal excursion and they must comply with the Road Code and the prefectural and municipal by-laws in force and have proper lighting and a reflective yellow vest if those-These are necessary.

They must move in a way that respects nature and its environment.

The waste goes into the pocket and then into a garbage can!

They will have to be covered by a Civil Liability insurance: they will make a declaration on the honor.

#### Wearing a helmet is highly recommended!

In the event of an accident, the responsibility of Roue Sportive de Meximieux (organizer of this permanent hike) can under no circumstances be engaged.

## **Article 6: Right to image:**

By registering, participants waive their right to the image. (Photographs and films that can be made by the organizer).

#### Article 7: Protection of personal data:

In accordance with the European regulation on the protection of personal data (2016/879), the organizer - Roue Sportive de Meximieux - wishes to provide the following information:

They will have to be covered by a Civil Liability insurance: they will make a declaration on the honor. Wearing a helmet is highly recommended! In the event of an accident, the responsibility of the Roue Sportive de Meximieux (organizer of this permanent hike) can under no circumstances be engaged.

- only the following data: last name, first name, age, club and country of origin will appear on the dedicated site in the section 'charts';
- the other data collected (telephone, email, address, date of birth) will not be disclosed and will not be the subject of any assignment to third parties;
- the unpublished data will be kept for one year and the published data will be kept for an unlimited period;
- concerning the data concerning you: you have access rights; rectification rights; erasure rights (in this case you will disappear from the list); opposition rights; limitation of the processing (this can have an effect on membership and appearance on the charts); to withdraw your consent; to portability. You can exercise these rights by mail addressed to the head of the brotherhood.

Any entry shall be deemed to be acceptance of these Rules.
